

Proceedings of the Technical Bid Committee meeting held under the Chairmanship Deputy Secretary(GAD) to the Government of Himachal Pradesh on 20.09.2018 at 3.00 P.M. for opening & evaluation of Technical bids for hiring of helicopter(s) by Himachal Pradesh Government.

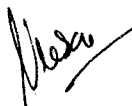

At the outset the Chairman welcomed the Sub-Committee members & representatives of the bidder companies and the purpose of meeting was explained

to them. It was informed that Himachal Pradesh Government intends to hire a Twin Engine helicopter with carrying capacity of minimum 15 passengers and a Twin Engine Medium helicopter with carrying capacity of minimum 5 passengers for multipurpose use of State Government including VIP duty, emergency evacuation/relief operations etc. Accordingly tenders were invited on 5.09.2018 from the interested parties.

Only one Party viz M/s Sky One Airways Pvt. Ltd., New Delhi has responded to the Tender Notice and submitted their technical & financial bids for Twin Engine helicopter with carrying capacity of minimum 15 passengers. Further, two Parties viz. Global Vectra Helicorp Ltd. and Thumbby Aviation Pvt. Ltd. have responded to the Tender Notice and submitted their technical & financial bids for Twin Engine Medium helicopter with carrying capacity of minimum 5 passengers within stipulated time on 20.09.2018. The Technical bids of all three companies were opened on 20.09.2018 at 3.00 P.M. by the Technical Bid Committee in the presence of representatives of companies after taking the signatures of the members of Committee as well as representatives of companies on main envelopes.



Technical bids of Global Vectra Helicorp Ltd. and Thumbby Aviation Pvt. Ltd. for helicopter with capacity of minimum 5 passengers were examined by the Committee in the beginning. The technical bid of Thumbby Aviation was found to be in order and qualified the conditions of Tender document and considered eligible. The technical bids of Global Vectra Helicorp was also found to be in order and may be considered eligible subject to the condition that as per clause 3(iii) (Rejection criteria) of the Tender document the concerned company may furnish declaration that they have not modified any part of bid document, before opening of financial bids.

Technical bid of Sky One Airways Pvt. Ltd. for helicopter with capacity of minimum 15 passengers was also examined by the Committee. During evaluation it has been found that as per clause 2.23 of Tender Document the bidder has to position alternate helicopter of similar capacity within 15(Fifteen) days of issue of Letter of Intent(LOI) which should not be more than 7 years old. During evaluation/discussions it has been found that Sky One Airways, if considered for award of contract, will provide the alternate helicopter from their existing fleet of 04(Four) Mi-172 helicopters which are more than 10 years old. Since, Sky One Airways Pvt. Ltd. is unable to meet the mandatory requirement to provide alternate helicopter of not more than 7 years old, hence, the Technical Bid Committee considered Sky One Airways Pvt. Ltd. as technically ineligible.

It has further been decided that the ineligible bidders shall be given more time to make its representations i.e. till 25.09.2018 at 4.00 PM. The representation may be addressed to the Deputy Secretary(GAD) to the Government of H.P. through E-mail at gadbr1-hp@nic.in. The representations, if any, received shall be again examined/considered by the Technical Bid Committee and issue(s) shall be brought before the Secretary (GAD) to the Government of Himachal Pradesh for decision. Consequently, the final decision of eligible/ineligible shall be hosted on official website of GAD (www.himachal.nic.in/gad/) on 25.09.2018. The financial bids of technically qualified bidders will be opened on 26.09.2018 at 4.00 PM in the office chamber of Additional Secretary (GAD) to the Government of Himachal Pradesh, Room No. 229 (Armsdale building) H.P. Secretariat, Shimla-2.

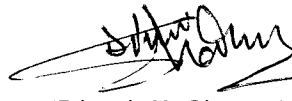

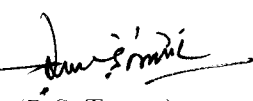

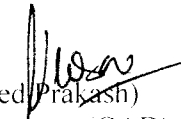
