At the outset the Chairman welcomed the Committee members & representative of the bidder company and the purpose of meeting was explained to them. It was informed that Himachal Pradesh Government intends to hire a Twin Engine helicopter with carrying capacity of minimum 15 passengers and a Twin Engine Medium helicopter with carrying capacity of minimum 5 passengers for multipurpose use of State Government including VIP duty, emergency evacuation/

relief operations etc. Accordingly tenders were invited on 5.09.2018 from the interested parties.

M/s Sky One Airways Pvt. Ltd., New Delhi which submitted its bids in response to the Tender Notice for Twin Engine helicopter with carrying capacity of minimum 15 passengers was considered Technically ineligible as the company was unable to meet the mandatory requirement to provide alternate helicopter of not more than 7 years old in accordance with clause 2.23 of Tender Document. Further, two Parties viz. Global Vectra Helicorp Ltd. and Thumby Aviation Pvt. Ltd. have submitted bids in response to the Tender Notice for Twin Engine Medium helicopter with carrying capacity of minimum 5 passengers. The Technical Bid Committee had considered Thumby Aviation as technically qualified and Global Vectra Helicorp was considered eligible subject to the condition that as per clause 3(iii) (Rejection criteria) of the Tender document the concerned company may furnish declaration that they have not modified any part of bid document, before opening of financial bids.

Thus, the Financial Bids of Thumby Aviation Pvt. Ltd. and Global Vectra

Helicorp Ltd. were to be considered by the Financial Bid Committee. It was noticed by


the Committee that representative of only Thumby Aviation Pvt. Ltd. appeared before the Committee. Whereas, the Global Vectra Helicorp Ltd. neither sent its representative for opening of the Financial bids nor furnished declaration under clause 3(iii) of the Tender document before opening of Financial Bids.

Since only one company i.e. Thumby Aviation Pvt. Ltd. remained eligible for opening of Financial Bids, the Committee, unanimously, decided that in view of only one eligible bid, the tender process be cancelled without opening of Financial Bids. The inconvenience caused to stake holders was deeply regretted.
