All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops will remain closed on the said date in the above mentioned area.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in above Ward of Municipal Corporation, Shimla, on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.


